FYI

- Limits shown as X/X/X (such as 100/300/100) are typically detailed as “\$X for bodily injury to or death of one person in any one accident and, subject to said limit for one person, \$X because of bodily injury to or death of two or more persons in any one accident, and \$X because of injury to or destruction of property of others in any one accident.”
- Limits show as \$X CSL, (such as \$500,000 CSL), are **C**ombined **S**ingle **L**imits.
- Standard Filing Forms are typically a Form E (liability insurance), Form G (liability surety bond), Form H (cargo insurance), or Form J (cargo surety bond).
- Renewal Required pertains to an “automatic” annual renewal of an insurance filing. All states requiring filings require a “replacement” filing in the event an existing filing expires or is canceled. This column only relates to purely intrastate carriers and those carriers whose operations are exemption from interstate/intrastate renewal preemption (hazardous materials, waste, recyclables, household goods, or non-consensual towing.)
