Dear Secretary Peters:

On January 14, 2008, the Board of Directors of the Unified Carrier Registration Plan ("Board") voted to: a) withdraw its previous 2008 recommended fees and fee brackets and b) recommend that you keep fees and fee brackets for the 2008 registration year at the same levels as previously set for the 2007 registration year². Significant to its decision is the Board's understanding from the Federal Motor Carrier Safety Administration ("FMCSA") that if fees and fee brackets are kept at the same levels for 2008, a more expedited process, namely an adjudication as opposed to a rulemaking, would be utilized in setting 2008 registration year fees and fee brackets. In making its new recommendation, the Board decided that a more expedited process is preferable because it avoids confusion to all parties involved in the Unified Carrier Registration Plan caused by a gap in registration years, mitigates revenue loss to the States, and allows more time to implement an effective roadside enforcement program.

The Board also understands that FMCSA has requested the Board submit a revised calculation of State revenue entitlements for 2008 in the event the Board decided to withdraw its original 2008 recommendation. Therefore, attached please find a table detailing State entitlements for 2008.

The Board further understands that FMCSA asks the Board to affirm that the annual fees set in 2007 will be sufficient to provide the revenues to which the States are entitled for 2008. Although the Board cannot guarantee that the annual fees set in 2007 will be sufficient to provide the revenues to which the State are entitled to for 2008, the Board believes with more time to register entities subject to the UCR Act, some of whom did not register in 2007, along with implementation of certain practices by the States, such as

checking that carriers register in the correct bracket, combined with a meaningful roadside enforcement program, that the States will be made whole in 2008. As stated in its previous 2008 fees and fee brackets recommendation letter to you dated October 22, 2007, the Board stands ready and willing to assist you in setting a fee structure for 2008 as soon as possible.
