Dear Mr. Hugel:

In order to facilitate the states' processing of UCR applications; to provide adequate and easily assessable information to enforcement officials (for both roadside and audit purposes); and, to assist the affected industries to be in compliance with the UCR requirements, the following modifications are requested:

- Display the quantity of power units and of trailers (from the MCS-150) on <u>www.safersys.org</u>. This will allow motor carriers to review these numbers prior to registering under the UCR program and assist the states in processing UCR applications.
- 2. Request SAFER contain multiple years of UCR registration data. This will allow regulators/administrators to readily determine if an UCR and was registered for a previous year as well as a subsequent year. The UCR Board prefers to have three (3) years past history available.
- 3. Request a location on the MCMIS database to log UCR undeliverable mail. The majority of states received about 22% of their 2007 UCR mailouts returned as undeliverable. That's approximately \$33,500 in lost revenue in postage alone (that figure does not include the cost of the mailing itself). This field should then be available to be utilized to screen carriers for future mailings. Would also like FMSCA to initiate a rulemaking making a carrier out-of-service for failure to maintain a valid insurance on file.

Note: We also received several returned with "Deceased" marked on them. We would like to know how to process these (or to advise survivors accordingly).

4. On the UCR search of www.safersys.org, a user must depress the SEARCH button for the search to be performed. We request the search to be executed even when the ENTER key is depressed.

5. On a carrier's Snapshot display (http://www.safersys.org/query.asp) - upper right hand corner of the screen add a UCR link, i.e.,

Other information for this Carrier SafeStat Results Licensing & Insurance UCR

- Display both Legal Name and DBA on the UCR results screen. This will assist in verifying the correct search was performed (http://www.safersys.org/UCRQueryForm.aspx).
- 7. Add an entity type of "Leasing Company" to the list available for entities applying for USDOT numbers (current types are carrier; hazardous materials shipper, both a carrier and a shipper or a registrant). This will allow leasing companies to comply with the UCR registration requirement without unduly burdening state and national UCR systems as well as allow the data to be imported and displayed in FMSCA's systems.
