

**UNIFIED CARRIER REGISTRATION AGREEMENT**

**STATE PLAN**

I, William C. Gore, Jr., Commissioner of the Department of Transportation, Division of Motor Vehicles, on behalf of the State of North Carolina, (State) pursuant to Section 14504a of 49 U. S. Code (established by Section 4305 of the Unified Carrier Registration Act of 2005, Public Law 109-59), do hereby certify as follows:

1. The North Carolina Department of Transportation, Division of Motor Vehicles has or will have the legal authority, resources, and qualified personnel necessary to administer the agreement in accordance with the rules and regulations promulgated by the Board of Directors of the Unified Carrier Registration Plan pursuant to Section 14504a of 49 U. S. Code;
2. The State shall demonstrate that an amount at least equal to the revenue derived by the State from the Unified Carrier Registration Agreement shall be used for motor carrier safety programs, enforcement, or administration of the Unified Carrier Registration Plan and Unified Carrier Registration Agreement; and
3. The State intends to participate in the Unified Carrier Registration Agreement.
