Dear Mr. Gutierrez:

At the Unified Carrier Registration (UCR) Plan Board of Directors (Board) meeting on February 21, 2008, the Board voted unanimously to defer to the National Conference of State Transportation Specialists (NCSTS) the setting of a recommended enforcement date for the 2008 UCR Agreement (UCRA) registration. In response, I held a teleconference meeting of the NCSTS state representatives on March 5, 2008, to establish a recommended 2008 UCRA enforcement date.

By consensus, June 1, 2008, was chosen as the recommended 2008 UCRA enforcement date on a national level. Participating in this meeting were NCSTS representatives from 39 states of which 36 were in agreement with the June 1<sup>st</sup> enforcement date.

June 1<sup>st</sup> is a recommended enforcement date as NCSTS understands that it does not have the authority to mandate an enforcement date. In fact, it should be noted that some states intend to begin enforcement prior to June 1<sup>st</sup> for carriers based in their respective states.
