RE: 2009 UCR Registration

Dear Avelino:

At our recent Annual Conference in Louisville, KY, the NCSTS membership discussed several items concerning the upcoming 2009 registration period for the Unified Carrier Registry (UCR). It was agreed that NCSTS strongly urge the UCR Board to require the following of all member jurisdictions:

- A) 2009 UCR applications must be mailed by the States during September 2008.
- B) The National Self-Registration system must be ready to accept 2009 UCR applications on September 1, 2008.
- C) 2008 fee collections must be reported by non-Indiana system participating states no later than January 5, 2009 to Frank Laqua, chairman of the UCR depository subcommittee.

In addition, NCSTS recommends that the national enforcement date for 2009 be set for January 1, 2009.
