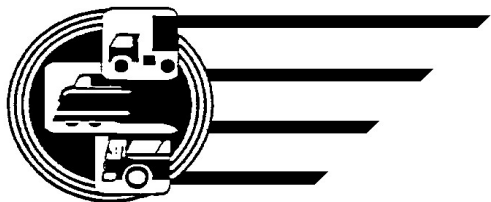

Please make plans to attend the NCSTS 62nd Annual Conference to be held at the Kimpton Hotel Monaco in Portland, Oregon, from Sunday, June 7, through Wednesday, June 10, 2020. In addition to the NCSTS conference, the Unified Carrier Registration Board will host training on Monday, June 8, and the Board meeting Tuesday morning, June 9. NCSTS presentations will be on Tuesday afternoon, June 9 through Wednesday, June 10. We encourage state UCR training participants to stay for the NCSTS Conference as it should prove extremely informative to motor carrier regulators and state administrative staff. The UCR Board will reimburse trainees only through Monday night for lodging purposes, so each State would need to cover the extra day(s) lodging and NCSTS Guest Fee not covered by UCR (Note: the guest fee covers only the Conference meal costs per individual).

Please use the following link: [2020 NCSTS ANNUAL MEETING](#) to make lodging arrangements. The reservations department is also available 24 hours a day at **1-800-711-2971**. All reservations must be made under the “**2020 NCSTS Annual Meeting**” room block or “**JiU**” room block code in order to receive the group rate (UCR will not reimburse above the group rate). That rate is the federal per diem of \$192/night. There are a few Queen suites (2 beds) at \$207 for single or double occupancy. Valet parking is \$25/night. Please reserve now so that we can secure your room at the federal per diem rate before it is sold out.

The registration fee for the NCSTS conference is \$230 which includes the President’s Reception/dinner on Tuesday evening, June 9. NCSTS Guests and UCR Training participants may participate for a fee of \$135. Please submit your registration form to NCSTS Treasurer Carol Fallin no later than April 1 so that we can obtain an accurate head count for meeting space and meals. Send registrations to:
